## **KVKK APPLICATION FORM**

### **GENERAL DESCRIPTIONS**

The related individuals (hereinafter referred to as “Applicant”) defined in 6698 Law on Protection of Personal Data (“KVK Law”) are defined with the right to make certain requests under Article 11 of KVK Law regarding their personal data.

According to paragraph 1 of Article 13 of KVK Law, applications regarding the rights must be submitted to us in written and signed format or by other methods set forth by the Personal Data Protection Board (“Board”).

Accordingly, the “written” applications to our Company should include the printed version of this form and shall include

- Personal application of the Applicant,
- via notary,
- by being signed by the Applicant with “safe electronic signature” under 5070 Law on Electronic Signature

and send via registered electronic mail address of the Company.
